Wells Fargo Shareowner Services (WFSS) is authorized to deposit my dividend payment by electronic funds transfer in the United States financial institution account indicated below. WFSS is authorized to initiate corrections to any amount transferred in error, and any claim against WFSS or the financial institution involved is waived with respect to the operation of this service. This authorization will remain in effect until WFSS receives notice to terminate or revise it. WFSS and the financial institution reserve the right to terminate this service at any time. It is the shareholder's responsibility to notify WFSS of changes in financial institution information. Frequently Asked Questions about Direct Deposit of Dividends through Wells Fargo Bank, N.A., Dividend Disbursing Agent

What is a "routing number" or "ABA number"?

It is an identification number assigned to the bank or bank branch at which your checking or savings account is located. It is usually located at the bottom of your check or savings deposit slip.

A routing number must start with a 0, 1, 2, or 3. Please contact your bank to obtain the correct routing number for your checking or savings account if the routing number on your deposit slip does not start with 0, 1, 2 or 3.

If I sign up for Direct Deposit will it start immediately?

A. Direct Deposit will begin with the next dividend payment, provided your authorization is received before the dividend record date.

How do I obtain a Medallion Signature Guarantee stamp?

The Medallion Signature Guarantee stamp can be obtained through an eligible financial institution that is a member of a Medallion Guarantee Stamp Program.
